For the first option, you will not be able to use your Bluetooth device. You can go to Control Panel \ All Control Panel Items \ Update & Security, and make sure the Windows Update feature is on. Click on Start and click on Settings \ Personalization Click on Updates and Windows Update. Click on Turn Windows features on or off. Click on Change.
